

## **Contemporary Considerations and Models for Transitions of Care Services**



Transitions of care is an area of clinical practice in which pharmacists can have an impact as health systems attempt to identify methods that ensure continuity of patient care across a variety of settings. There is not a clear best practice for transitions of care in ambulatory care; thus the role of the pharmacist can be multi-faceted. This session will describe three ambulatory care structural models in addition to justification for pharmacist involvement.

#### DAVID MARX, J.D.



Mr. David Marx is president of Outcome Engenuity, a Dallas-based risk-management firm. He has a B.S. in Mechanical Systems Engineering and a J.D. in Law. His firm currently focuses primarily on helping high-risk organizations develop safety-supportive practices and culture.

Mr. Marx began his career as a Boeing aircraft design engineer. In his final years at Boeing, he organized a human factors and safety group, which won the International Whittle Award for development of a human-

error investigation process now used by air carriers around the world.

In 1997, he launched a research and consulting practice focusing on the management of human error through the integration of systems engineering, human factors, and the law. He has served as an advisor to the Federal Aviation Administration's Human Factors Research Program and to the NASA Space Shuttle Program.

In the healthcare sector, Mr. Marx was the principal consultant guiding the State of Oregon and the Oregon Health Care Association to build the first statewide, quantitative model of medication safety risk. In the area of safety culture, he authored for the National Institutes of Health the document "Patient Safety and the 'Just Culture': A Primer for Healthcare Executives." Mr. Marx's Just Culture tools have now been implemented at a statewide level in both Minnesota and North Carolina. In November 2005, his firm launched the Just Culture Community, a Web-based resource for organizations striving for more open learning cultures. In December 2005, the Institute for Safe Medication Practices awarded him the Cheers award for his work in developing the Just Culture.





# **FEATURED SPEAKERS**

#### NICHOLAS TATONETTI, Ph.D.



Dr. Nicholas Tatonetti is assistant professor of biomedical informatics in the Departments of Biomedical Informatics, Systems Biology, and Medicine, as well as Director of Clinical Informatics, at the Herbert Irving Comprehensive Cancer Center at Columbia University. He received his Ph.D. from Stanford University, where he focused on the development of novel statistical and computational meth-

ods for observational data mining. Applying these methods to drug safety surveillance, he discovered and validated new drug effects and interactions. His lab at Columbia is focused on expanding on his previous work in detecting, explaining, and validating drug effects and drug interactions from large-scale observational data.

Widely published in both clinical and bioinformatics, Dr. Tatonetti is passionate about the integration of hospital data (stored in the electronic health records) and high-dimensional biological data (captured using next-generation sequencing, high-throughput screening, and other "omics" technologies). Dr. Tatonetti has been featured in The New York Times, Genome Web, and Science Careers. His work has been covered by the mainstream and scientific media and has generated thousands of news articles.

#### JOAN S. ASH, Ph.D., M.L.S., M.B.A.



Dr. Joan S. Ash is professor and vice-chair, Department of Medical Informatics and Clinical Epidemiology, School of Medicine, Oregon Health & Science University (OHSU), Portland, Ore. She holds master's degrees in library science, health science, and business administration as well as a Ph.D. in systems science. Dr. Ash has served on the Board of Directors of the American Medical Informatics Association, the Board of Directors of the Medical

Library Association, the Biomedical Library and Informatics Review Committee of the National Library of Medicine, and as chair of the Board of Scientific Counselors for the Lister Hill National Center for Biomedical Communications of NLM. She has also served on two of the Office of the National Coordinator (ONC) for HIT's Advisory Committee work groups. She is an elected fellow of the American College of Medical Informatics.

Dr. Ash's research focuses on behavioral and social issues related to implementing clinical information systems, specifically computerized provider order entry (CPOE) and clinical decision support (CDS), as well as the use of qualitative methods for conducting such studies. Her research team has conducted national surveys of CPOE use and its unintended consequences as well as fieldwork in 25 organizations to investigate success factors and unintended consequences related to CPOE and CDS. The team has also conducted fieldwork to investigate the safety of electronic health records, with results leading to publication of the SAFER guides by the ONC.



# **340B Update and Challenges with Limited Distribution Drugs**




